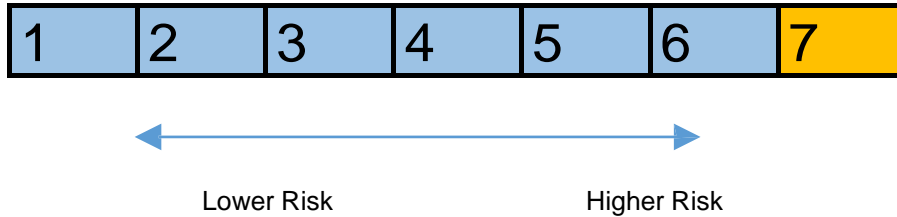
### WHAT IS THIS PRODUCT?

<b>Type</b>	Over the Counter Derivative (OTC) – FX Forward
<b>Objectives</b>	<p>The objective of this product is to provide protection from adverse movements in foreign exchange currency rates above pre-agreed levels, ending on the expiry date. It is one of the tools available to manage your foreign exchange (FX) rate risk.</p> <p>A forward contract is a binding contract between you and AIB to exchange a specific amount of two currencies at an agreed rate, on an agreed future date(s).</p> <p>The contract exchange rate (forward rate) is agreed at the time the forward contract is booked. The forward rate is the spot rate plus or minus the forward points which are calculated from the interest rate differential between the two currencies.</p> <p>There are two types of forward contracts:</p> <ul style="list-style-type: none"> <li>• fixed forward contracts where the drawdown is due to take place on as specific, pre-agreed future date; and</li> <li>• time option (sometimes called window) forward contracts where drawdown may take place between two stipulated future dates in one or more drawdowns.</li> </ul> <p>Once you have executed a contract at the forward rate you cannot benefit from any subsequent favourable exchange rate movements. You are obliged to use the rate regardless of where the spot rate is at maturity. 100% of the invested amount is protected at maturity.</p>
<b>Intended Investor</b>	This product is intended for Irish retail businesses wishing to mitigate the exchange rate risk associated with ongoing trade transactions, but can also be used by individuals who require exchange rate certainty for specific future transactions, such as the purchase or sale of an asset denominated in a foreign currency.
<b>Term</b>	Forward contracts can be booked in all major currencies for periods greater than spot value (i.e. from 3 business days) up to typically one year. The expiry date of the forward contract will be set out in the confirmation for the product. It is a product which is entered into for its term, although early termination may occur in the event of a default by either you or AIB.

NOTE: The EU Regulation on **Packaged Retail and Insurance-Based Investment Products (EU 1286/2014)** (“**PRIIPs**”) imposes new pre-contractual disclosure requirements for the benefit of retail investors when they are considering the purchase of “packaged” retail investment products or insurance based products.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. For the purposes of determining market risk, PRIIPs are divided into 4 categories. Category 1 cover PRIIPs that fall within one of the categories referred to in items 4 to 10 of Section C of Annex 1 to Directive 2014/65/EU of the European Parliament and of the Council. The MRM (Market Risk Measure) class for Category 1 PRIIPs shall be 7. We have classified this product as 7 out of 7, which is the highest risk class.

If you cannot fulfil your contract, you may not be able to terminate it easily before maturity or you may have to end your product at a price that significantly impacts on the performance of your product. In some circumstances you may be required to make payments to pay for losses. **The total loss you may incur may be significant.** This product does not include any protection from future market performance so you could incur significant losses. In the event that AIB is not able to pay out what is owed, you could incur significant losses.

### WHAT HAPPENS IF FTB IS UNABLE TO PAY OUT?
