

## Commercial Buildings in the UK: Approach to selecting the top 15% energy efficient buildings (derived from Governmental publications)

This document is sourced completely from the latest Governmental data releases and publications from England & Wales<sup>1</sup> and Scotland<sup>2</sup>.

This memo serves as an executive summary of the respective data releases in the context of identifying a suitable threshold to select the top 15% of energy efficient commercial buildings in England & Wales and Scotland and should be read alongside the full publications.

This document also includes conclusions, which are made to provide clarity, explanation and context for its purpose. The conclusions are not part of the data releases and publications.

### *Definitions/clarifications:*

**EPC (Energy Performance Certificate)** – An Energy Performance Certificate for a building in the UK. Methodologies to calculate EPC labels within the UK are different regionally, hence Scotland and England & Wales are considered separately.

**Domestic building EPC** – residential building EPC

**Non-domestic building EPC**– commercial building EPC

<b>Total non-domestic buildings in England &amp; Wales<sup>4</sup></b>	<b>2,073,070</b>
<b>EPC coverage vs. total stock</b>	<b>42.9%</b>

Table 1 shows the distribution of EPC's for commercial buildings in England & Wales as of June 2019. Analysing the data to obtain the cumulative totals shows that the threshold within the top 15% equates to commercial buildings with an A, A+ or B label; this equates to a cumulative total of 9.8% of buildings within the EPC database.

The coverage of commercial buildings with an EPC label currently equates to around 43% of all commercial buildings in England & Wales. This means that commercial buildings holding an EPC A, A+ or B label belong to the top 9.8% most energy efficient commercial buildings in England & Wales. As it is expected that new buildings are overrepresented in the EPC database, extending the analysis to the entire building stock would very likely result in an even lower share of than 9.8%.

Table 1 shows the distribution of EPC's for commercial buildings in Scotland as of end 2017 (published in June 2019). Analysing the data to obtain the cumulative totals shows that the threshold within the top 15% equates to commercial buildings with an A, B or C label; this equates to a cumulative total of 13.5% of buildings within the EPC database.

The coverage of commercial buildings with an EPC label currently equates to around 21% of all commercial buildings in Scotland. This means that commercial buildings holding an EPC A, B or C label belong to the top 13.5% most energy efficient commercial buildings in Scotland. As it is expected that new buildings are overrepresented in the EPC database, extending the analysis to the entire building stock would very likely result in an even lower share of than 13.5%.
